English Australia Submission: 2013 ASQA Cost Recovery Impact Statement

## Background

The Australian Skills Quality Authority (ASQA) was established as a cost recovery agency in accordance with a decision made by the Council of Australian Governments (COAG).

Australian Government Cost Recovery Guidelines require that agencies conduct regular reviews to ensure that appropriate cost recovery is occurring.

ASQA has undertaken a review of fees and charges utilising financial and activity data from its first year of operations. The review took into account additional funding that was provided in the 2012–13 Commonwealth Budget and increased cost recovery requirements. The results of the review revealed that ASQA's current fees and charges are not recovering the costs of regulatory activity.

A revised schedule of fees and charges has been developed for implementation from 1 July 2013 in order to meet cost recovery requirements. The proposed changes are explained in ASQA's 2013 Cost Recovery Impact Statement—Exposure Draft.

ASQA has released the 2013 Cost Recovery Impact Statement—Exposure Draft for public comment. The statement includes an explanation of the proposed fees and charges and demonstrates that ASQA's cost recovery arrangements comply with the Australian Government Cost Recovery Guidelines.

ASQA has invited written submissions in response to the proposed fees and charges by a deadline of Tuesday 9 April.

ASQA is interested in receiving feedback on the:

- design of ASQA's proposed fees and charges;
- clarity of ASQA's proposed fees and charges;
- impact of the proposed fees and charges on the sector.



## **Context – English Australia & the ELICOS Sector**

English Australia welcomes this opportunity to provide comment on ASQA's 2013 Cost Recovery Impact Statement—Exposure Draft.

**English Australia**, formerly known as the ELICOS Association, is the national peak body and professional association for the English Language Intensive Courses for Overseas Students (ELICOS) sector. English Australia was established in the early 1980s and incorporated in 1990.

English Australia represents 100 member colleges across Australia. More than 80% of all overseas students who study English in Australia do so with an English Australia member college. English Australia has both public sector (eg attached to a university or TAFE) and independent language centres among its membership.

**The ELICOS sector** has a 100% international focus as it provides courses only to students from overseas and has no domestic education focus. The ELICOS sector plays a critical role in preparing international students with the language skills they need for further study in Australia as well as offering a range of programs to students wishing to learn English for a multitude of other reasons.

As the first step in the educational 'pathway' for many international students, the ELICOS sector is the first to experience any shift in demand. The sector is highly vulnerable to changes in the external environment, with short courses (average course length is 12.6 weeks) and short lead-times for enrolments.

**The last three years** have seen a **significant decline in the number of ELICOS students**, with the number of commencing student visa holders down by almost 30% when compared with the peak year of 2009<sup>1</sup>. The ELICOS sector has been hit the hardest of all sectors by the decline in international student numbers.

With the continuation of a strong Australian \$, price has become a major factor impacting on Australia's ability to attract students to this sector. The ELICOS sector in particular is **extremely price sensitive** as the most commoditised educational product worldwide. ELICOS colleges have had to manage an environment of **declining revenues and escalating costs**, with compliance costs increasing as a result of a range of reforms to the Education Services for Overseas Students (ESOS) Act<sup>2</sup> as well as the costs associated with ASQA regulation.

The ELICOS sector is a **highly competitive** sector, particularly in the context of pricing. The competitiveness within the sector has been recently challenged further by the division of the sector into two separate groups, those regulated by ASQA and those regulated by the Tertiary Education Quality and Standards Agency (TEQSA).

An ELICOS college regulated by ASQA is competing directly with another ELICOS college in the same city which is regulated by TEQSA. In this context the question of whether these two colleges are competing on a level playing field needs to be asked.

### **Executive Summary**

The following three points outline the key issues that English Australia has to make regarding the proposed changes to ASQA fees and charges.

- English Australia would first of all like to question the appropriateness of a situation whereby some providers in the ELICOS sector are subject to ASQA and a fee structure based on a cost recovery model, whilst other providers in the same sector are subject to TEQSA which does not operate on a cost recovery basis. English Australia calls for a review of the fairness of the two fee structures as they apply to ELICOS providers.
- In relation to the annual CRICOS registration fee, English Australia asks that ASQA consider returning to a per course fee model or a model which breaks the fee down into more reasonably sized 'blocks' of qualifications, for example a different fee for blocks of 5 qualifications.
- English Australia requests clarification as to whether there are any fees associated with the accreditation /approval of non-award ELICOS courses and if so how the fee would be assessed (as the workload would be different to that required for approving an AQF qualification).

Further detail regarding these points is provided below.

### **English Australia comments**

English Australia welcomes this opportunity to provide comment on ASQA's 2013 Cost Recovery Impact Statement—Exposure Draft.

ASQA is interested in receiving feedback on the:

- design of ASQA's proposed fees and charges;
- clarity of ASQA's proposed fees and charges;
- impact of the proposed fees and charges on the sector.

As outlined in the introduction to this submission, the ELICOS sector has experienced a tough three year period of declining student numbers and any increase in ASQA fees is going to have a negative impact on their competitiveness.

#### Equity, fairness and competitiveness

English Australia would first of all like to question the appropriateness of a situation whereby some providers in the ELICOS sector are subject to ASQA and a fee structure based on a cost recovery model, whilst other providers in the same sector are subject to TEQSA which does not operate on a cost recovery basis. English Australia calls for a review of the fairness of the two fee structures as they apply to ELICOS providers.



English Australia has undertaken an analysis of the comparative annual fees for an average ELICOS provider under both TEQSA and ASQA as follows (see Appendix B for more detail regarding the calculations):

ASQA (proposed)	\$4,866 per annum
TEQSA (current)	\$1,000 per annum

Under the proposed model, ASQA regulated ELICOS providers will be paying almost 5 times more than TEQSA regulated ELICOS providers each year.

### Appropriateness of fee structure design

Putting aside the issue of whether the cost recovery nature of the proposed charges could be challenged, English Australia would like to look in more detail at the design of the fee structure as proposed and whether it is fair to ELICOS providers.

The proposed increase in fees for a typical provider will result in their amortised annual payment to ASQA more than doubling from the existing \$2,348 per annum to \$4,866 per annum, an increase of 107%.

If we break this down into the 5 yearly component and the annual component, the comparison is as follows:

- the 5 yearly registration renewal fee will increase from \$4,740 to \$6,955, an increase of 47%;
- the annual fee will increase from \$1,400 to \$3,475, an increase of 148%.

It is difficult to find justification in the paper for such a large increase in the annual fee and this is the component that English Australia wishes to query.

The majority of ELICOS providers are not Registered Training Organisations and do not deliver AQF qualifications.

The fees that an existing non-RTO ELICOS provider would be liable for on a regular basis (excluding changes to scope) are:

A key change that would seem to be unfair to small providers is the change from charging a fee of \$100 per qualification to charging a blanket fee of \$2,525 per year for 3-50 qualifications. As the table in Appendix C shows, if a provider only has 3 qualifications, the annual fee increases by 2425%. Colleges don't 'break-even' until they offer 23 courses. The typical ELICOS college profile would involve much fewer than 23 courses.

English Australia asks that ASQA consider returning to a per course fee or breaking the fee down into more reasonably sized 'blocks' of qualifications, for example a different fee for blocks of 5 qualifications.



### **Relevance to ELICOS**

It is unclear from the documentation provided what fees are associated with the accreditation/approval of non-award ELICOS courses. Currently the term 'qualification' is defined as follows:

'Qualification' includes training package qualifications, VET accredited courses or programs.<sup>3</sup>

There is a section of the CRIS document that refers to VET course accreditation fees (p38), however it is unclear whether this refers to non-award ELICOS courses.

English Australia requests clarification as to whether there are any fees associated with the accreditation /approval of non-award ELICOS courses and if so how the fee would be assessed (as the workload would be different to that required for approving an AQF qualification).
