### Assessment Level

The consolidated sectoral reporting distributed to SVP providers by the DIPB policy section indicates the risk index by citizenship, taking into account refusal of student visa applications, cancellation of student visas, and students who become unlawful.

# Verification of English Certificates

Certificates should be examined for recycled documentation, photo similarity (certificate vs passport photo), evidence of tampering with the image (eg, substitution of results), etc.

# **Previous Study**

Education providers may wish to confirm applicants' previous study has been at a university or other chartered higher education institution recognised by the Council of Boards of School Education in India (COBSE). COBSE has confirmed that any institution not listed on their website as a registered board is not in compliance with Indian Legislation and therefore, documentation provided by non-listed institutions are not accepted as valid education documents.

# Nigeria

Education Providers are advised to remain vigilant for fraud in the Nigerian caseload, particularly with financial, employment and educational documents.

### **Bank statements**

Education providers may wish to confirm that Micro-Finance banks have been listed as an approved financial institution by the Central Bank of Nigeria.

**Certificates of Incorporation –** Even though a Certificate of Incorporation issued by the Corporate Affairs Commission may be a genuinely issued document, such a document does not, of itself, constitute evidence that the company in question is an active company.

**National Youth Service Corps –** Nigerian nationals who have obtained a Higher National Diploma or Bachelor Degree are required to complete a year of community service. A National Youth Certificate will be issued which will confirm that a Higher National Diploma or Bachelor Degree was obtained.

### **National Tax Number (NTN) verification**

The Federal Board of Revenue (FBR) website requires the client's NTN and Computerised National Identity Card (CNIC) number to verify if a person or business are genuine tax payers.

### **Educational certificate check**

A number of institutions have online verification of educational documents from Intermediate (Year 12) through to Master's degrees/certificates. Records generally include the students' roll numbers, selected subjects and examination years, and are maintained for up to five years.
